





Vattenfall Clashindarroch Wind Farm Community Fund

Fund report - Year 1

This report covers the operation of the Fund from 1 June 2015 to 30 June 2016

Introduction

The Vattenfall Clashindarroch Wind Farm Community Fund is provided by Vattenfall AB, the owner of the Clashindarroch wind farm in Aberdeenshire. The Year One donation to the Fund from Vattenfall (excluding fees) was £185,000. Donations are index linked (Retail Price Index) and in Year Two will be £187,359.

The area of benefit for the Fund comprises the areas covered by the community councils of Huntly, Strathbogie, and Tap o' Noth, and Cabrach Community Association.

The Fund makes grants of over £500 with no upper grant limit, although applications for over £25,000 have to go through a two stage process before approval.

The Fund provides grants to support charitable activities which will support positive change and

strategic impact in the area of benefit. In particular the Fund will support projects which:

- improve community services and facilities
- increase participation in and access to contemporary culture, events and recreational activity
- preserve and enhance the natural environment for residents and visitors
- promote rural regeneration
- celebrate the area's cultural, historic and archaeological heritage.

The Clashindarroch Community Fund Panel makes decisions on how the Fund is spent, and promotes the Fund locally. The Panel comprises two nominees from each of Huntly, Strathbogie and Tap o' Noth Community Councils, and from Cabrach Community Association, who are joined by a community representative for each area.

Fund Overview

In the period from 1 June 2015 to 30 June 2016, a total of 29 applications to the Fund were received over three rounds. This gives an average of 9.7 applications per round. One application received has yet to be determined and was continued to the September 2016 Panel meeting. One application was withdrawn before it went to the Panel.

The Panel made 22 awards to 21 organisations to deliver 22 projects. This gives a conversion rate from application to award of 76% over the report period. One award was subsequently withdrawn as the applicant was unsuccessful in obtaining the necessary match funding. In total four applications were rejected; two were rejected because the Panel felt there was not enough local benefit being shown for the area; one was rejected as the structure of the applicant meant it was not eligible; and one was rejected as a sufficient case had not been made for an award, and the applicant was invited to reapply.

The Panel can make multi-year awards and to date £124,468.24 (67% of Fund income) has been awarded from Year 1 of the Fund to projects, £35,375 from Year 2 of the Fund, and £10,375 from Year 3 of the Fund (a total awarded of £170,218.24), while 0.05% (£88.50) has been used for Panel expenses.

For the initial few years, £85,000 of the annual fund payment has been set aside for legacy or capital projects. In Year 1 £40,790.98 was awarded from the legacy part of the Fund, and £83,677.26 from the rest of the Fund.

The average award over the report period was £10,009. The lowest award was £1,500 (made to Aurora Youth Choir) and the highest award was £60,000 (made to Rhynie Community Facilities Development Charitable Trust – this was the award which was subsequently withdrawn). The total value of projects funded for all years to date (all funding sources and excluding the withdrawn award)) was £341,440 giving a leverage ratio of 50.1%; for every £49.90 awarded from the Fund, a further £50.10 was raised from elsewhere.

For Year 1 projects in the Huntly area were awarded 32.5% of all funds awarded, those in the Strathbogie area received 32.1%, those in the Tap o' Noth area received 26.4%, those in the Cabrach area received 7.4%, and those benefitting all four areas received 1.5% of all funds awarded. However, all but 3.5% of the awards made for Huntly were to organisations based in Huntly but also active outside it.

The balance carried forward from 2015-2016 to 2016-17 was £14,787.71.

What Difference is the Fund Making?

The 22 awards made over the first year were used to support a variety of activities as shown in Appendix A. The Fund has supported projects that impact on many different aspects of community life, from the improvement of village halls, to the provision of recreational activities such as woodworking, rugby, canoeing and cycling.

Completion reports are required to be submitted by awardees. Generally awards are for projects that are planned to complete within 12 months of receiving an award. Foundation Scotland allows three months from this completion date for the return of reports, before writing to awardees to chase outstanding reports. At the time of writing (August 2016) only one completion report had been received as yet.

Below are three case studies that demonstrate how the Fund is making a difference.

Case Study 1

Cabrach Community Association was awarded £6,956 towards the cost of painting, fitting curtains, and installing a dishwasher and kitchen shelving in The Acorn community hall (formerly the local primary school). The work has been carried out and contributes towards creating a bright, welcoming atmosphere in the building, which allows the community to hold functions and social activities in The Acorn in relative comfort.

Case Study 2

Cairnie Memorial Hall Committee was awarded £23,740.98 towards the cost of preparing and resurfacing the ground areas at the front and sides of the hall in order to improve the parking facilities. The Committee has spent the last few years refurbishing the interior of the hall and fundraising to pay for that, so hopefully this will be the last piece in the refurbishment jigsaw required, and the Committee will be able to take a well-earned rest when the work is complete.

Case Study 3

Huntly Rugby FC was awarded £25,000 over three years to increase the hours of its rugby development officer, and to extend his contract until January 2019. This award will allow the Club to develop a longer-term, sustainable rugby training and playing schedule for children and young people in the area, which should provide them with an opportunity to transition through the different levels of participation within the sport. It will also give the Club a funding base from which to attract other funding and business sponsorship for its youth programme.

Marketing and Communications

Foundation Scotland, alongside the Fund Panel, has worked to raise the profile of the Fund through a variety of channels during the first year of the Fund, some of which are set out in the table below.
