# 1. Welcome, Introductions and Apologies

# 2. Minutes of the meeting on 25 March 2019

## 3. Matters arising

#### 3.1 Case studies

IC has nearly finished a batch of case studies. They largely await photos. These will need to go on to the NorthConnect web-site as well as the Fund web-pages.

These were all issued after the last funding round, with three themes: youth, community facilities, off-shore; and generated more local coverage than previously. IC will send electronic versions to FM.

The sci-art schools project will no longer be going ahead. EGCP was grateful to the Panel for considering the application and for its feedback.

#### 4. Fund Statement

IC had previously circulated a statement showing funds available at 20 November 2019 of -£7.00. The next donation of £20,000 from NorthConnect would arrive shortly. IC was advised to include the bank transfer charge for the last payment and this payment in the invoice.

Three of the grants awarded in March 2019 had not yet been drawn down - Aberdeenshire Sailing Trust, Collieston Community Development Group, and Rediscover Peterhead, the first two as they were still pursuing match funding.
