Fund update

The Glenkerie Wind Farm Community Fund is provided by Ventient Energy, the owner and operator of Glenkerie Wind Farm. Decisions on grant awards are made by the Community Fund Panel, whose membership is drawn from the Upper Tweed and Tweedsmuir Community Councils and the wider community.

The Fund will support activity that will help to provide access to services for all community members; improve local transport; grow the local economy; and develop or maintain community assets. It began to make awards in 2014. Since then, the Fund has...

Projects in focus

Biggar Rugby Football Club

In 2018 Biggar Rugby Football Club (RFC) was awarded a grant of £8,244 as a contribution towards implementing the club's communication plan and to employ a



communications co-ordinator, with match funding coming from the club's own funds.

The project enabled the creation of a new website and significantly improved the club's use of social media, providing an ability to easily communicate via a range of mediums, linking them together and sharing information with the club's 400+ members.

During the pandemic, when activities were shut down, the communications co-ordinator kept the club members engaged and in touch through challenges for the youth sections, quizzes, and videos etc.

Projects in focus

Skirling Village Hall

Skirling Village Hall was supported with a grant of £3,414 in September 2019 to contribute to completing improvement the and modernisation of the hall through the upgrading of its lighting system.

The grant part-funded the project along with funds from SSE Clyde Borders Community Fund.

The upgrades were started in January 2020 and completed in February 2020. The new batten-type LED lighting system is more flexible and environmentally friendly than the previous overhead strip lighting.



The modernised hall is warmer and more attractive for holding a variety of activities and social events to benefit the population of Skirling and its surrounding areas, and it will be more economical to run, making it more sustainable.
