# **Tannach** RWE Tannach Community Funds



Tananch and District Community Council works in partnership with Foundation Scotland to manage different funds donated for the benefit of the community. The arrangement provides for a streamlined application for grantees. The current Donors are Gresham House Asset Management, owner of Wathegar 1 and Wathegar 2 wind farms and RWE, owner of the Bilbster wind farm.

#### **History of Awards**

Since the **Bilbster Community Fund** was transferred to Foundation Scotland in 2019 awarded two the Fund has grants, distributing just over £5,000.

The Wathegar 1 Fund launched in 2014 and has awarded 39 grants, distributing over £180,000.

The Wathegar 2 Fund launched in 2019 and has awarded five grants, distributing over £23,000.

The Tannach and District Wind Farm Education & Training Fund launched in 2019 and has awarded 18 educational awards to individuals distributing over £40,000.

#### **Community Funding**

Any constituted community group delivering a project which will benefit the residents of Tananch and District can apply to the Fund.

During this reporting period the Panel has considered four applications, all of which were awarded. The four projects were:

- **1. £4,000 to Yarrows Heritage Trust** to contribute to the Swartigill Archaeological Community Dig in September 2021.
- **2.** £224 to Wick Model Yacht Club to fund the groups insurance for a year.
- **3. £7,500 to Wick Academy Football Club** to replace the Club's 17-year-old mower.
- **4.** £19,976 to Tannach and District Community Council for new play equipment at Haster playpark from toddlers to teens.

#### **Education and Training**

This fund has been up and running since late 2019 and residents are slowly beginning to apply and see the value of it. Over the last year 10 residents applied for funding in a range of subjects including:

- 3. Post Grad Cert Autism and Learning
- 4. Health Coach Institute certification
- 5. BA International Business Management
- 6. BSc Computer Science

- 9. Earth and Environmental Science (Hons)
- 10. SVQ Professional Cookery

The purpose of this fund is to improve local people's opportunities for employment. You don't have to be unemployed to apply. The process is quick with awards made usually within a month of receiving the application.
