

CAIRNRYAN COMMUNITY FUND UPDATE WINTER 2022

Welcome to the first Cairnryan Community Fund newsletter. We hope you it find it interesting.

Cairnryan receives funding from two windfarms - Glen App, which is owned by ScottishPower Renewables; and North Rhins, which is owned by Schroders Greencoat. In 2018 the Community Council formed the Cairnryan Community Fund which pooled these two sources of money into one Fund, with a combined set of rules and application processes, to make it easier to distribute and access. Together these two funds are worth around £30,700 per year - the exact sum paid out each year depends on the Retail Price Index. During the pandemic, the Fund accrued and currently there is a balance of over £100,000 which can go towards making some great projects happen in the village.

The Community Fund can be used to support all sorts of community-led activity in Cairnryan, such as running costs for local groups, sessional worker costs, community consultations, maintenance of community facilities and more. The Fund also supports bursaries for education and training - you can read more about this overleaf.

An Advisory Panel decides on grant awards from the fund. This Panel is made up of people who live in the area. You can read more about the Panel and how you can join it in this newsletter. Foundation Scotland is a grant-making charity with a local team, and it supports the Panel and does the grant management and fund administration.

SPOTLIGHT ON.....



Cairnryan in Bloom

Purpose of Award: To contribute to the cost of purchasing planting and maintenance of flowering plant displays in the village.

Award: £3,500

Since April 2015, Cairnryan in Bloom volunteers have worked to improve the appearance of the village by planting bulbs and flowering plants and maintaining the planters along the village road and outside the hall. In 2019 Cairnryan in Bloom built 12 new planters to replace old ones and increased the number of in the village. They also bought a motorised water bowser to help the volunteers to water the planters in dry weather. The group has five regular volunteers from the village who maintain the planters and plan the displays each year. In 2021 the Fund made a three year grant award to cover the cost of materials and plants, so that the group could plan ahead. The attractive planters show pride in the community, for residents, visitors, and ferry traffic. The grant will support the work of the group and help to improve the environment of Cairnryan.

CAIRNRYAN EDUCATION & TRAINING FUND

The Fund Panel was delighted to launch the new Education & Training Fund in 2022.

Did you know that this Fund is not just for school leavers but for anyone in the Fund area of benefit who is looking for support with the costs of accessing training or education opportunities? If you're not sure this is you get in touch.

The fund has been created to help support access to opportunity and improved livelihoods. This new fund feels more relevant than ever as we all face increasing living costs.



Grants are available for short courses and multi year courses, up to a maximum of three years and £3,000. Travel, subsistence and childcare costs can be supported. THE COMMUNITY FUND PANEL



The Cairnryan Community Fund Advisory Panel decides on grant awards from the fund. This panel is a separate thing from the Community Council. It's made up of people who live in the area and includes spaces for at least two members of the Community Council and up to ten other members of the community. During the pandemic there were lots of challenges for all of us - and the Fund Panel, like many things, was affected by health issues and the challenge of moving to meeting online, which meant projects like the Community Action Plan went on ice. However the Panel is very much back to business, as you can see from all the activity in this newsletter **and looking for new members!**

If you are interested and have time to attend three or four meetings a year in the Hall, **please get in touch**. You don't need any special skills or experience, just love for the area and an interest in how community benefit money can be used to best benefit everyone who lives there.

CAIRNRYAN COMMUNITY ENERGY GRANT

The Fund Panel has opted to make £300 available to all eligible households in Cairnryan this winter, to help offset the rising cost of energy bills. This is a one-off grant being made this year in the light of the current cost of living crisis. Here's the guidance:

- The grant is for domestic main residences only commercial premises, second homes and commercial holiday lets are not eligible to apply
- The residence must be within the Cairnryan Community Council boundaries
- Only one application is allowed per household
- Proof of residency will be required, using a Council Tax notice in the name of the applicant
- A bank statement matching the name on the Council Tax notice is needed to make payment
- Applications can be made any time from the 21st November to the 31st March 2023.

How do I apply?

The easiest way to apply is to email your application with a copy of your Council Tax notice and Bank Statement to **grants@foundationscotland.org.uk** - you can find all the info and the one page form at **www.foundationscotland.org.uk/cairnryan.** If you're not online, don't worry - you can use the tear out form at the back of this newsletter and come along to the Cairnryan Community Christmas Cuppa on **Saturday 10th December** (keep reading for more information on this) - Suzy from Foundation Scotland will be there - don't forget to bring your Council Tax notice and matching bank statement with you!

CAIRNRYAN COMMUNITY ACTION PLAN

If you haven't already heard, the Fund Panel commissioned a Cairnryan Community Action Plan from Creetown Initiative in early 2022. The aim of creating a plan was to gather up everyone's aspirations for the village, and to do this in a way that made sure that everyone who wanted to have a say, got an opportunity to provide their views on what they think is important to help make Cairnryan the best possible place to live.

There are around 100 households in Cairnryan. Creetown Initiative distributed a survey to all identified households, which had a 31% return rate; they also held a drop in event in the Hall, attended by 16 people; and had informal one to one conversations with nine representatives from the Community Council and the Fund Panel. The consultation helped identify the top priority projects, which the Community Action Plan summarises as:



The Community Action Plan helped identify that there are groups within the community already who could between them tackle some of these priorities - groups such as the Community Council, the Cairnryan Hall, Welfare and Facilities Group and Cairnryan in Bloom. It also identified that there are some projects that the community couldn't tackle directly themselves, such as the issues with speeding or the Council-owned public toilet, but that the Community Council might be able to lobby the statutory authorities on these issues, using the evidence gathered from the community consultation. Finally it identified that for some projects, specialised professional advice might be needed, and for that, external paid support could be required.

The Plan also helped highlight where the Community Fund might be able to provide grant support using the c.£30,000 year received into the Fund - and which of the bigger and more ambitious projects will need additional funds from other sources to get them complete.

SPOTLIGHT ON.....



The Cairnryan Hall, Welfare & Facilities Group (or Cairnryan Group for short) is a membership group for residents which has recently been formed as a not for profit company, with a view to being able to help deliver on community priority projects and some of the key projects in the Community Action Plan.

As you may have spotted from its webpage http://cairnryangroup.co.uk/group.html, the group has been repairing the Village noticeboard and doing some maintenance on the coastal path. Another priority for the group is taking on a Management Agreement from Dumfries and Galloway Council so that the community can run Cairnryan Hall, with the aim of seeing more community social activity taking place inside.

The group's Chair, Nick Scott, says the group warmly welcomes new members and volunteers – to become a member you simply need to be over 16 and a resident. You can also ask for any notices you want posted on the group's web page, which will act like a virtual village noticeboard.

The Fund is administered by Foundation Scotland, an independent grant making charity with local presence, which has a longstanding track record in supporting communities to manage and distribute community benefit funds.

Foundation Scotland has a South of Scotland team and was contracted in by Cairnryan Community Council to provide Fund administration - this means running the awards processes, supporting the Fund Panel decision making about how to distribute the Fund and doing the required reporting to the wind farm owners.


